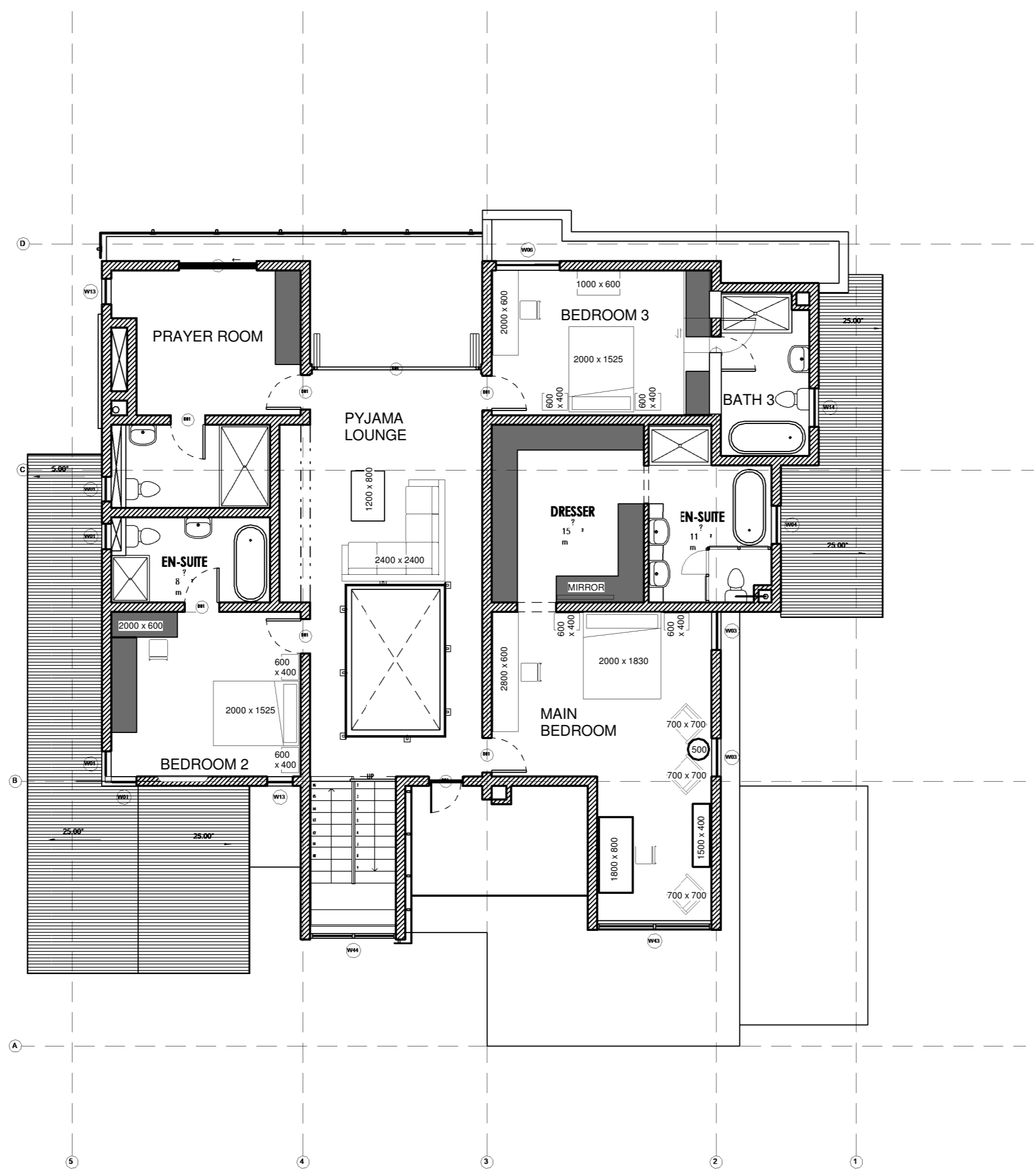

 - LAWS AND REGULATIONS**
 - All works and building materials are to comply with National Building Regulations (SANS10400) and Building Standards Act No. 103 of 1977, as amended.
 - All work to be carried out in strict accordance with by-laws and regulations of the relevant local authority.
 - Light and ventilation are to comply with part (f) of NRBS.
 - DRAWINGS**
 - Shop drawings must be approved by the client PRIOR to the manufacture of any shopfitting or items.
 - Detail drawings must be prepared to arrangement drawings.
 - One set of drawings are to be kept on site at all times.
 - All revised drawings are to be clearly marked "REVISION #", and a copy of the revised drawing is to be handed to the contractor.
 - DIMENSIONS**
 - Contractors and subcontractors are to check and verify dimensions and detail levels before commencing with any work.
 - Figured dimensions are to be taken in preference to scaled dimensions.
 - VARIATIONS, REVISIONS AND AMENDMENTS**
 - The designer is to be notified of any variation by the Project Manager.
 - All relevant detail, levels and dimensions of any work done, must be checked on site by all contractors. Any discrepancies are to be reported to "Crazy Angel Designs" immediately.
 - CONTRACTORS AND SUBCONTRACTORS**
 - Contractors must ensure the structural stability of all components of their work and ascertain that the main structure is capable of supporting all loads applied therein.
 - All electrical and drainage work is to be executed by registered artisans, and the relevant Certificates of Compliance to be issued to the client upon completion.
 - SHOPFITTED ITEMS**
 - Shopfitted items are to be measured on site and shop drawings are to be approved by the designer AND client PRIOR to material order and manufacture.
 - PARTITIONS**
 - All partitions on outside walls are set out from centre lines of columns or window mullions. Any dimensional errors should be accommodated within these parameters.
 - All partitions to be rodent proofed and have a minimum of 30 minute fire rating.
 - All partitions to comply to SANS082.
